# Notice of Traffic Management, Risborough Road, Stoke Mandeville

High Speed Two (HS2) is the new high speed railway for Britain. We continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. ### What are we doing?

As part of our continued preparatory works, we will be carrying out some works on Risborough Road (A4010) in Stoke Mandeville.

We will be moving a section of pavement to enable the future installation of a temporary Bailey bridge over Risborough Road. The purpose of the bridge is to keep our construction traffic within the site as much as possible and to reduce the impact on public roads.

For the safety of road users and our staff, these works will require temporary traffic management, in the form of traffic lights, along a section of Risborough Road.

### When will these works take place?

Risborough Road will have traffic management for approximately two weeks, commencing from mid to late January. We will work to open the roads to reduce disruption as soon as possible.

Should there be delays to our works, these dates may be subject to change.

Works will take place between 9am and 3.30pm – Monday to Friday. Some additional weekend work may also take place.

8.00am – 1.00pm

Noise from plant and equipment used for the works

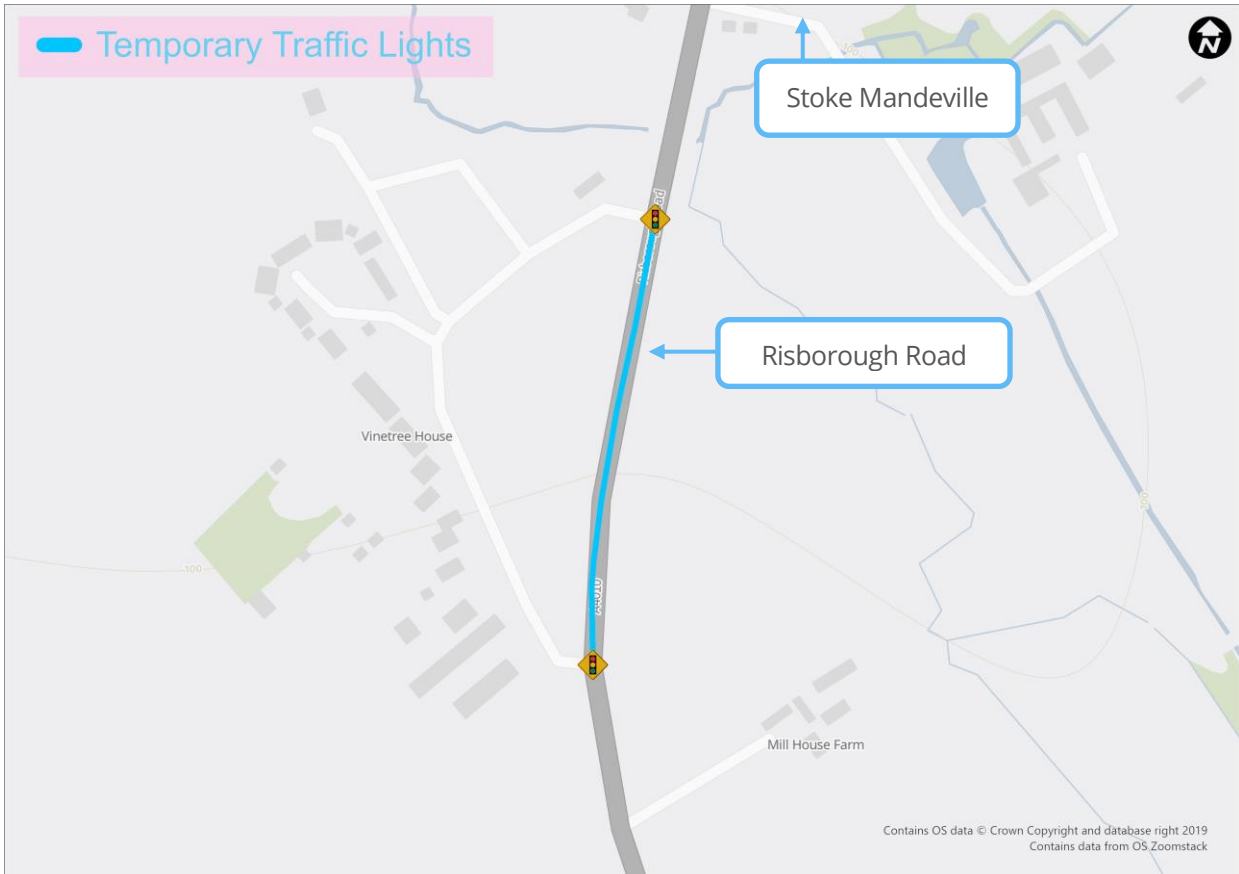

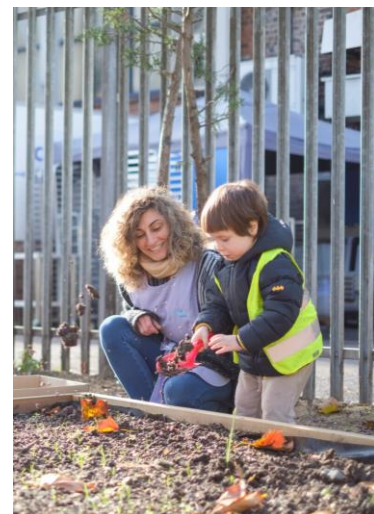
## About our Community and Business Funds
