Minutes of the Kimble Stewart Hall Annual General Meeting held on Wednesday 4th September 2019 at 7.00 pm in the Stewart Hall Committee Room

1. Apologies and Attendance

2. Minutes and Matters not arising elsewhere

The Minutes were approved and signed at the last meeting

3. Chair's Annual Report – see attached

Sue Howgate told the Committee that she felt it was important to stress how many compliments she had received about the hall and wanted to thank everyone concerned and the volunteers. The biggest challenge this year had been the heating breaking down and thanked everyone who had helped solve this crisis.

There are two new people who have joined the Committee:- Penny Standen and John McVay. The Committee thanked Julie Bunker for her hard work while undertaking the role of Treasurer especially answering all of HSBC's many questions regarding money laundering checks.

4. Election of Officers

Chair – Sue Howgate seconded by Delia Burton Vice Chair – Delia Burton seconded by Gerald Redding Treasurer – Penny Standen seconded by Julie Bunker – Julie to continue until Nov. 30th Secretary – Maggie Kaye seconded by Delia Burton Sue Howgate confirmed that we are still looking for new members to join the Committee.

5. Treasurer's Annual Report

Julie Bunker distributed the annual audit from Roger Nash which have been signed off. - see attached

There followed a discussion as to why there was a deficit in the net profits and this was due to the following factors:-

There had only been one fund raising event during the year and there had been no Bucks Art Week in June and November. There had been increased expenditure for electrical works and the refurbishment of the hall. There was the loss of the Thursday morning Art Group and a potential hirer didn't go ahead with bookings as planned as they didn't get sufficient interest.

It was discussed that there needs to be a reserve figure for a new boiler if needed and also there would be some outgoings on work in the outside car parking areas.

A discussion took place as to how to raise the profile of the hall but it was felt that no bookings through the website should be available as Amanda, the bookings Secretary screens potential hirers. It was decided that more publicity was needed and various ways were discussed by the Committee.

Julie Bunker will ask Roger Nash if he could recommend anyone accredited to do the audit next year.

Sue Howgate thanked Julie for all her hard work.

6. Future Development of the Hall

Sue Howgate and Gerald Redding reported to the Committee that the Sound System and speakers had been delivered. Terry Kaye has been asked to build a lockable cabinet and the speakers will go either side. Once the system is set up it should not need any input from hirers.

7. Any Other Business

John McVay informed the Committee that he has been asked by Remi Chapman if he could draw up a to scale floor plan of the hall for the outstanding emergency lighting work (the present set up is not sufficient and doesn't meet current regulations). Gerald Redding added that there were no lights in the middle of the hall or in the Committee Room and estimates would be needed.

Brian Butler wanted to pass on thanks from the Horticultural Society Committee for keeping the hall in such good condition. Sue Howgate thanked him for this.

Notes for Action

- SH informed the Committee that the Scottish Power tariff is about to end so she will make enquiries from them.
- SH reported that Doreen our cleaner is a lot better but will still need further convalescence. DB wondered about getting professional cleaners and this will be looked into.
- JB reported that the window cleaners for the hall outside windows had not sent an invoice so she will contact them.
- Race Night RN and DB will ring contacts from last year. JM has agreed to sell tickets and contact villagers on the app who may be interested. RN will buy alcohol and soft drinks. DB has organised the licence, flyers and posters to go out. JB will put the event on the Parish Council website. PS suggested putting the event on the Princes Risborough facebook and What's On.
- PS has been looking into putting on a village film night. ? to hire or buy film.
- DB reported on Tiny Hero's night on 7.12.19. They will cover any loss but it is hoped that 70 tickets will be sold. SH said we need to set the date.
- There followed a discussion about the patching up of the outside area as a temporary measure in the first instance.

You may have seen the damage to the hedge outside our house, hit last Sunday by yet another speeding driver who veered off the road he claims to avoid another car.

Luckily nobody was injured, but the driver, witnessed by Marcus and an independent passer-by admitted to driving over 40mph

So who knows what speed he was doing in reality. His insurance company has accepted in principle the cost for replacing and making

good the hedge so all will move on again soon once we find some landscapers to do it.

However, just hours before, Austin and his cousin had been playing on the other side of the hedge and would've been directly affected by this crash.

Over summer (Aug) I was asked to cut the encroaching hedge back from the road by the council, which I did and now as much visibility as can be offered is available for drivers to make sensible decisions as they enter the narrower part of the road between Marcus and Katie and ourselves.

I strim the verge myself monthly and tractors have been used to flail the overgrown hedge right back roadside. I do feel we have done what we can in terms of improving visibility for drivers. Even with cones and a hi-viz jacket there were screeching brakes, angry abuse, and skidmarks left on the road as drivers refused to slow in passing me while cutting the hedge back. Currently, with best visibility the cars are mostly still racing through at speeds well above the 30 mph.

We have erected our own Yellow back warning sign to indicate a concealed entrance approaches on their left, this has had no effect whatsoever.

To that end then I approached the council last week about a visit to site to see if they would view the damage, take a straw poll of car speeds driving through and take

a close look at the way the verge has eroded by larger vehicles waiting their turn to squeeze through the gap – they have just sent me the link below which

suggests first step is Parish Council considering a speed assessment survey for £400 at this end of the road.

I just thought to send TFB response below on for your/Parrish Council view please – the real concern for me is that a car has now come off the road and smashed into an area where my son could've been playing, and in fact was playing just hours earlier.

It does feel time now we have lived here a few years, and seen the speed of many vehicles increase between our part of the road and the junction at the end of the line it's time to try and address the speeding in this end of the lane?
