Great Kimble School – A4010 School crossing
 Correspondence between BCC, The GK School and the PC has concluded that the only likely solution
 here is the installation of a Pedestrian Refuge. However a feasibility study will need to be carried out to
 ascertain if even this will be appropriate. The Clerk will investigate the cost of a feasibility study and also
 an application for grant funding from BCC Participatory Budget scheme.

#### Report from Clerk

- Update on Affordable Housing Scheme
   An update from Hastoe Housing has been received; the houses are due for completion on 11<sup>th</sup> December 2013. The Shared ownership houses have all been reserved however the rental ones are not all allocated and this may be due to residents being unaware that they must register on the Bucks Homechoice website (<a href="www.buckshomechoice.gov.uk">www.buckshomechoice.gov.uk</a>) to be eligible to rent one. The Clerk will put a note on the website and in the Parish Magazine.
- Annual Account Returns from Mazaars
   The annual return has been received back from the External Auditors with no concerns but a note on the necessity to review our current asset register and notes on how this should be set up and managed.

The Clerk also reported that our Bank name has changed from Lloyds TSB to Lloyds Commercial Bank, our terms and conditions have not changed.

The Clerk had received several complaints about the line 300 bus service; buses are not stopping due to overcrowding, especially at peak times. On reporting this to BCC it would appear that the change to the 16+ School transport scheme has resulted in an increase demand as Arriva are offering cheaper travel than BCC. BCC have little power over this route as it is a commercial and not subsidised by them. All complaints should be forwarded to Arrive (customerservices@arriva-shires.com)
